

# Veteran, Military, and Dependent Checklist

## 1. DETERMINE ELIGIBILITY FOR EDUCATION BENEFITS – go to <https://www.va.gov>

If applying for Veteran's Benefits for the **First Time**, complete the VA Application for Education Benefits at [va.gov](https://www.va.gov).

**TIP:** Veterans - keep a copy of your DD-214 on hand to enter correct service dates  
Dependents – Have available the Social Security number of the parent who served time in the Armed Forces.

**TIP:** Active military members: reach out to your Education Services Officer (ESO), or counselor within the military, prior to enrolling at HGTC.

**TIP:** If you are a child of a Veteran you MAY be eligible for a tuition waiver for the South Carolina VA Benefit. [Click here for application and eligibility requirements.](#)

## 2. APPLY TO HORRY-GEORGETOWN TECHNICAL COLLEGE

Follow the standard Admissions Process at HGTC. Use this link to [apply for a degree or certificate program](#).

**TIP:** Veterans can have their admissions application fee waived by presenting their DD-214 or Military ID, or by contacting [admissions@hgtc.edu](mailto:admissions@hgtc.edu) for the Veteran fee waiver code.

**TIP:** You can apply to HGTC before receiving your Certificate of Eligibility form.

If you are a veteran and flagged for non-residency, please reach out to the Veterans Coordinator as you may be eligible for a residency waiver.

**TIP:** Once you have applied to college, you will receive a letter with your student ID number (H#) and password. Keep this letter in a safe place.

## 3. TRANSFER CREDIT

Order official transcripts from all colleges you have attended. Include any colleges you attended before, during, or after your military service.

Order your official military transcripts. Go to <https://jst.doded.mil>

#### 4. FAFSA

If you would like to apply for Federal and State Financial aid, complete the FAFSA (Free Application for Federal Student Aid) at [www.studentaid.gov](http://www.studentaid.gov). Our school code is 004925.

**TIP:** Veteran / Military Education recipients may be eligible for financial aid in addition to their benefits from the VA or military.

#### 5. STUDENT DEVELOPMENT COORDINATOR (ADVISOR) AND REGISTRATION

Once HGTC receives your transcripts, you will meet with a Student Development Coordinator who will evaluate your course work and assist in mapping out an Education Plan that will clearly define your education goals. This advisor will also assist you to register for classes.

#### 6. REQUEST FOR CERTIFICATION

If using VA Education benefits: Submit your Request for Certification to the Financial Aid Office or online at [Financial Aid Forms](#). (The form is near the bottom of the page)

A new Request for Certification form must be turned in each semester and should be completed prior to the payment deadline (posted on the student portal).

#### 7. SECURING PAYMENT FOR CLASSES

For students using Chapter 31 (VR&E) and Chapter 33 (Post 9/11), the Request for Certification form (step 6 above) will secure their classes.

Dependents using the State's Tuition Waiver: Stop by the Student Accounts office or email [studentaccounts@hgtc.edu](mailto:studentaccounts@hgtc.edu) PRIOR to the payment deadline, to sign the waiver form for that semester. This waiver covers tuition, but not fees. If financial aid is not covering the fees, the fees will be the responsibility of the student.

For Active Military students using Tuition Assistance: After you submit your classes on the TA portal for your branch of service, you should receive a confirmation email. Submit this email approval for the semester to [studentaccounts@hgtc.edu](mailto:studentaccounts@hgtc.edu) at least 7 days prior to the start of classes. Students using other types of veteran or dependent benefits will generally need to secure their classes with financial aid or set up a payment plan. Please reach out to [financialaid@hgtc.edu](mailto:financialaid@hgtc.edu) with questions.

## **8. STUDENT ID CARD**

Your student ID is used for identification purposes and checking out materials in the library. You can get your ID Card in TechCentral on each campus.

**TIP:** You will need to bring a photo ID and a copy of your class schedule.

## **9. ORIENTATION**

## **10. PARKING PERMIT**

A valid parking permit is required for all vehicles parked at any HGTC campus. There is no cost for the parking permit. Parking permits are issued for the entire academic year instead of individual semesters and may be picked up at the Public Safety Offices on each campus.

You will need a copy of your class schedule, car registration and student ID.

## **11. TEXTBOOKS**

Required textbooks and courses are listed in the class Instructional Package and can be found on the bookstore's website: <https://hortec.bncollege.com/shop/hgtc/home>.

Consider whether Post-9/11 book stipend funding and/or financial aid funding will be available to you by the time you need to purchase books. (VR&E students will be issued a book voucher. Please check with the VA coordinator for details).
