Graduates of HGTC's Dental Hygiene program are prepared to become licensed registered dental hygienists. As HGTC's Dental Hygiene program is accredited by the Commission on Dental Accreditation (CODA), students are eligible to take the written National Board Dental Hygiene Examination and a clinical Regional Board Examination, and become a Registered Dental Hygienist (RDH).
